

TOURNAMENT RULES



1. All times are central.
2. All participants must abide by the State of Florida Recreational Fishing Rules at all time.
3. Entry fee is \$250.00 per boat. The deadline for registration is 7:00 pm Thursday, July 23, 2009.
4. No mutilation of any fish is allowed.
5. No fish may be transferred from one boat to another.
6. All fish must be caught on days of tournament only.
7. Anglers must fish from registered boat.
8. Protests must be in writing and presented to the weigh master before the end of the tournament with a deposit of \$500.00 (cash only). If the alleged violation is found to have occurred, the full deposit will be refunded. If the Tournament Director / Tournament Committee finds no violation, the deposit will not be refunded. The decision of the Tournament Committee will be final.
9. The tournament will not be canceled or postponed due to weather or sea conditions. All anglers fish at their own discretion and risk. The tournament committee shall have the sole discretion to cancel either or both tournament fishing days (for hurricanes, tropical storms, small craft advisories, etc.)
10. One full day of fishing constitutes a tournament.
11. Any fish is subject to inspection.
12. Boats can leave out of Mexico Beach or Gulf County.
12. Weigh-in is from 4:00 p.m. until 5:30 p.m. Friday and Saturday. All participants must be in line and acknowledged by the weigh master by 5:30 p.m.
13. Fish category winners are awarded cash and plaques for first through third place in each of the following categories: 1st place \$1,500, 2nd place \$500, 3rd place \$250.
14. The grand prize winner will be determined through a point system. Points are awarded for the three heaviest fish in each category as follows: 1st—127, 2nd—73, 3rd—29. The sum of points accumulated for placements in the various categories determines the Grand Prize Winner.
15. In case of a tie, the first fish weighed is counted.
16. All winners must be present at the awards ceremony to receive check. No-shows will forfeit their check.
17. OPTIONAL ENTRIES: All boat entries have the option of entering any of the Jackpot prize categories, which requires an additional fee. The categories are as follows:
 - Wahoo – Level 1 \$100, Level 2 \$200, Level 3 \$300
 - Dolphin – Level 1 \$100, Level 2 \$200, Level 3 \$300
 - King Mackerel – Level 1 \$100, Level 2 \$200, Level 3 \$300One jackpot winner per species will be awarded based on the largest fish weighed per species. The winner of each jackpot will receive 80% of fees generated by the Level they entered and the level(s) below. A full explanation of jackpot rules and payouts will be explained at the Captain's Party.
19. Rules are subject to change. Final instruction and any changes will be given at the Captain's Party on Thursday, July 23, 2009 at 5:00 pm. It is strongly recommended that at least one angler from each boat attend.
